I. Application Information

1 Information on FGLP Scholarship

- **A.** Overview of Scholarship: This scholarship was raised with a donation from Shinsung Delta Tech Co., Ltd., global company, and a tuition scholarship offered by Gyeongsang National University, and is an industry-academic cooperation scholarship linked to scholarship, education, and employment.
 - ** Shinsung Delta Tech Co., Ltd. encourages FGLP scholars to be hired by one of its overseas corporations in Thailand, Indonesia, and Mexico

[Overview of Shinsung Delta Tech]

- No. of Employees: some 2,000 (800 in Korea, 1,200 overseas)

B. Scholarship Period: 2 years (4 semesters)

- In principle, scholarship students shall not take a leave of absence for two years after admission. However, where taking a leave of absence due to unavoidable circumstances, the period of absence shall not be included in the scholarship period.
- ** All expenses incurred after the end of the scholarship period shall be borne by the student himself/herself.
- C. Annual Scholarship: KRW17,360,000~18,754,000 (about 14,490~15,650US\$)

- ★★★ Tuition for the first and second semesters is unconditionally exempted, and tuition for the third and fourth semesters is exempted when a requirement for continuing scholarship payment is fulfilled.
- **E. Terms of Scholarship**: After graduation, FGLP scholars shall be hired by one of overseas corporations of Shinsung Delta Tech. Co. Ltd. in Thailand, Indonesia, or Mexico.

2 Important Notes

- FGLP is only a procedure for selecting scholarship students, and those who are selected as FGLP scholarship students must separately apply for admission of graduate programs (in May), Fall 2022. The admission guide will be delivered to successfully selected students only.
- 2 All documents must be written either in Korean or English.
- **3** Where the original documents are not written in Korean or English, they should be translated into Korean or English by the issuing institution or notary agency.
- 4) The evaluation and screening details will not be disclosed, nor the submitted documents will be returned.
- Applicants are required to put accurate and valid contact information in their application forms because GNU may reach you during the screening period. If an applicant fails to be reached by GNU, they should be responsible for any disadvantages caused by changes of contact number, contact interruption, not checking admission results, or failure to follow immigration procedures.
- **6** This guide is written both in Korean and English. If there is any difference in interpretation, the Korean version shall be only considered.
- Even if you are selected as a FGLP scholarship student, your acceptance will be revoked if you submitted false documents or were selected by any improper means.
- **3** The scholarship may be canceled if a successfully selected applicant fails to receive an adequate student visa before their study begins.
- **9** Admitted students are advised to stay in a GNU dormitory for their first semester.
- All international students must subscribe to the National Health Insurance during their school years. If you do not have the National Health Insurance, your visa extension and change will be rejected and you are banned from school scholarships and any benefit programs offered by GNU.
- New students are not allowed to take a leave of absence in their first semester. However, a leave of absence caused by the suspension of visa issuance, diseases, or pandemics may be allowed.
- Matters other than those specified in this Application Guide are subject to GNU regulations.

Eligibility for Application

- A. Nationality: Applicants and both their parents should have one of the nationalities Thailand, Indonesia, or Mexico.
 - X As of the application deadline, if a student/parents have more than one citizenship including Korean one, he/she is not eligible to apply.
- **B.** Educational Requirement: An applicant who has completed (scheduled) an undergraduate program corresponding to elementary and secondary education and university education of Korea or who is deemed to have equivalent education background under the relevant Korean laws.
 - X A successfully selected student who is scheduled to graduate must submit his/her bachelor's diploma by August 31, 2022 after receiving admission.
- C. Language Requirement: TOPIK 3 or higher
 - * An application may apply for the Dept. of **Management Information System (English track)** with TOEFL (PBT 530, CBT 197, iBT 71), IELTS 5.5, CEFR B2, or TEPS 600 (New TEPS 327).
 - A language certificate obtained after September 1, 2020, will be only recognized.
- **D. Grade Requirement**: An applicant whose overall grade in all undergraduate courses must meet one of the following conditions:
 - O C.G.P.A* 2.64/4.0, 2.80/4.3, 2.91/4.5, 3.23/5.0 or higher, or
 - * C.G.P.A. : Cumulative Grade Point Average
 - O Higher than 80% of a percentile converted score or within the top 20% in the class, or

O If the applicant's grade certificate does not provide a CGPA nor percentile score like above, an additional document that proves such a grade must be submitted by their home university.

E. Health Requirement

O An applicant must be healthy enough to study in Korea.

B. Selection Method

- 1) An applicant who passes the eligibility screening and achieves more than 80 points in evaluation by the applying department (program) will be successfully selected.
- 2) In principle, up to one candidate is selected for each department. However, if there is no eligible candidate for a department, the quota can be added to another department.
- 3) The final candidates who passed the eligibility screening and study ability evaluation are recommended to Shinsung Delta Tech Co., Ltd. to determine the successful candidates.


