Decision about the Accreditation Procedure

The ASIIN Accreditation Commission for Degree Programmes has decided that the information of responsible authorities is the responsibility of each higher education institution.

Please note that substantial changes in the structure, contents and the endowment of the degree programmes made within the accreditation period must be brought to our attention. Such changes would have to be examined by the Accreditation Commission for Degree Programmes.
